FULLFILLMENT

Implementation

- Create and remit invoice noted with payment terms to include Partnership will commence once all funds related to Partnership have been received.
- Upon receipt of funds, distribute <u>Partnership Benefit Menu (see attached)</u> and schedule follow up for assistance and possible modification i.e. transfer value of Fall Festival booth to another equally but more appropriate offering.
- Return agreed upon Benefit Package with implementation dates and other specifics as needed or requested.
- Update Partnership Tracker and advise bookkeeping for proper COA allocations. (see attached)
- File all related documents to member's files

Evaluation and Feedback

- Conduct regular reviews with partners to assess progress and address any challenges.
